



Surrounding Air Temperature


The rated temperature for all Units is 55°C.

Type NX-ID6142-6 is suitable for a maximum surrounding air of 50°C when all 32 input points are energized. It is suitable for 55°C when 26 input points maximum are energized. When using in a surrounding air temperature of over 50°C, maximum 26 of the input circuits shall be connected or the input circuitry shall be designed so that a maximum of 26 input points (13 input points per common) can be energized at a time.

Type NX-MD6121-6 is suitable for a maximum surrounding air of 50°C when all 16 input points are energized. It is suitable for 55°C when 12 input points maximum are energized. When using in a surrounding air temperature of over 50°C, maximum 12 of the input circuits shall be connected or the input circuitry shall be designed so that a maximum of 12 input points can be energized at a time.

- Use the recommended connector harness:XW2Z-□□□□ Series when you use NX-□□□□□□-6.
- Be sure to wire both terminals A9 and A18 (COM0) together, wire both terminals B9 and B18(COM1) together and set the same polarity for both pins when using NX-ID6142-6.
- Be sure to wire both terminals A9 and A19(COM0) together wire both terminals B9 and B19(COM1) together and set the same polarity for both pins when using NX-OD6121-6.
- Be sure to wire both terminals A9 and B9(COM0) together, wire both terminals A9 and B9(COM1) together and set the same polarity for both pins when using NX-MD6121-6.
- Be sure to wire both terminals COM together wire both terminals 0V together and set the same polarity for both pins when using NX-OD3268.







I/O Wiring Diagram



□: Over-current protection (current limitation :4A)






